- THIS IS HOW IT WORKS -

On September 1st of each year, the Registrar will contact (via email) all parties on the Wait List and ask them to indicate whether they are still interested in a site or not. They will have 48 hours to respond. Names on the list who do not respond will be eliminated. They will also have the option to refuse a site for the next season

and retain their place on the Wait List for one more year with this option being allowed only once.

Those still wanting sites will be contacted on September 16th (via email) with a list of sites available for the next season. They will be asked for their order of preference and an indication as to which sites they will or will not take. Renters will have 48 hours to respond. The sites will then be allocated based on these responses and their respected position on the Wait List.
